SCHEDULE OF FEE CLASSES & RATES

The business occupation tax is based on the total gross receipts of the business in combination with the most current profitability ratio, number of employees and flat rate of \$50.00 per the first \$20,000.00 of gross revenue. The employee tax rate is \$13.00 from 0 to 1 employee and \$13.00 for each additional employee. An administrative fee of \$75.00 is non-refundable and is levied on all applications except professional practitioners paying the professional flat fee. (See below)

PROFESSIONAL PRACTIONERS

Professional Practitioners may select to pay a flat fee of \$400.00 per practitioner or compute their fee using the gross receipts method.
