	 License requirements Resident caterers. Resident caterers must hold a valid Off Premise Caterers License. In order to distribute or sell malt beverages, wine or distilled spirits at an authorized catered function, a licensed alcoholic beverage caterer shall file an application for an off-premises event permit (Form R154) to the city at no additional fee. Excise taxes are imposed upon the sale of alcoholic beverages by a resident caterer. 							
>	 Permit requirements Nonresident caterers. A nonresident alcoholic beverage caterer is required to submit an application for an off-premises event permit to the City. The original off-premises event permit shall be kept in the vehicle transporting the alcoholic beverages to the catered event or function. It shall be unlawful for a licensed alcoholic beverage caterer to distribute, sell, or otherwise dispense alcoholic beverages off-premises except as authorized by the off-premises event permit. Excise taxes are imposed upon the total of individual alcoholic beverage drinks served by a nonresident caterer in the amounts set forth in the Code of the City of Johns Creek and shall be paid within 30 days after the conclusion of the catered event or function. 							
>	A licensed alcoholic beverage caterer may sell or otherwise dispense only that which is authorized by his alcoholic beverage license. For example, if the alcoholic beverage caterer possesses a valid license to sell malt beverages, he may sell or otherwise dispense only malt beverages at the authorized catered event or function.							
>	Sunday sales. An alcoholic beverage of Sunday sales license and comply with on Sunday.
